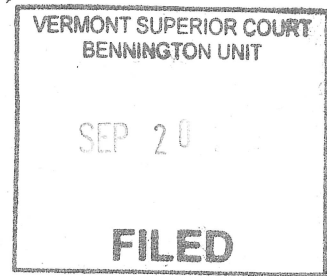


WAIVER OF EXTRADITION PROCESS

I, David Delratez, hereby acknowledge that I am the same person charged at Berkshire County, Massachusetts, with the crime of Violation of Probation - Felony, and that I have been informed of my rights and the nature of the process, and of the proceedings relative to my Extradition from the State of Vermont to the State of Massachusetts, County of Berkshire, and that I am entitled to be extradited; and that I hereby declare my willingness to return to the jurisdiction of Berkshire County, State of Massachusetts, without being under an extradition warrant and I expressly waive my rights to be extradited herein.

I sign this waiver without being under any fear, produced by threats; **willingly, freely and voluntarily** and without any duress or persuasion of any kind being made or used upon me, and without any promise of immunity, for the Prosecution being made to me.

ORDER FOR INTERSTATE RENDITION OF FUGITIVE

Based on COMPLAINT AND PETITION FOR INTERSTATE RENDITION OF FUGITIVE filed by the State of Vermont, Bennington County, in connection with the above captioned matter the Court HEREBY FINDS THAT:

1. The respondent is the person charged in the demanding State with having committed the crime alleged there;
2. The respondent "probably committed the crime," which is punishable by imprisonment of more than one year;
3. The respondent has fled from justice from said State.

AND FURTHER, THE COURT HEREBY ORDERS

- has occurred the extradition process and shall*
1. That the respondent appears thirty days from this date for surrender on *return to Massachusetts. Massachusetts shall*
the Governor's Warrant or hearing on Motion to Extend Time on *return of funds on a budget 1/27/11 in the interim,*

COMPLAINT AND PETITION FOR INTERSTATE RENDITION OF FUGITIVE

Now comes the State of Vermont, by and through the Office of the Bennington County State's Attorney, on oath of office, and hereby files this complaint alleging as follows:

1. That David Delratez is a fugitive from justice from the State of Massachusetts.
2. That the above named respondent has been convicted of a crime in said State punishable by a term of imprisonment of more than one year, a warrant issued for his/her arrest on September 13, 2013.
3. That probable cause exists to show that the respondent was convicted of a crime, and has an outstanding arrest warrant as alleged by the demanding State.
4. That respondent is the same person sought by the authorities of the demanding State.

In support of said complaint, the affidavit of David Dutcher of the Bennington Police Department is attached hereto and incorporated by reference.

The State hereby petitions that the Court make the following findings:

1. That the respondent is the person alleged to have committed the crime in the demanding State;
2. That the respondent is charged with a crime which is punishable by imprisonment of more than one year and a warrant issued for his arrest on September 13, 2013.
3. That the respondent has fled from justice from said state; all based upon the affidavit(s) attached hereto.

FURTHER, the State petitions the Court to Order:

1. That the respondent appear thirty days from this date for surrender on the Governor's Warrant or hearing on Motion to Extend Time on .
2. That the respondent shall execute and comply with such terms of bail and conditions as the Court shall deem appropriate or, if the respondent shall fail to meet the terms thereof; that the respondent be committed to jail until the date and time as set forth in paragraph (1) above.

The undersigned, Sgt. David L. Dutcher, after being duly sworn under oath deposes and says, I am now and have been for the past 25 years a regular member of the Bennington Police Department. I was on duty September 19, 2013 as a Police Sergeant.


I believe David Delratez was then and there a person who is wanted in the State of Massachusetts for a crime that is punishable by a term of imprisonment of more than one year, because:

On 09-19-2013 I received a phone call from Det. John LeClare, North Adams Police Department requesting assistance with an investigation. Det. LeClare advised they had developed a person of interest (David Delratez) and were able to get a GPS location on his cell phone yesterday (09-18-2013 1505 hrs) on Valentine Lane off of Pleasant Street in Bennington, VT. Det. LeClare advised they were looking for a vehicle Delratez may be driving, MA passenger registration 88ZA27, a 2005 Ford Taurus color blue with white plates and red digits.

Det. LeClare further advised they believed Delratez has friends in the Bennington area, Dennis Pratt, Ricky Arnold and a Connie "Pratt/Winnie/Rock/King".

Affidavit

I responded to the Pleasant Street, Valentine Street area and did not see the vehicle. I returned to the station house and Spoke with Sgt. Rowland and Det Urbanowicz, giving them the information Det. LeClare had given to me. Along with Cpl Hunt, they responded to the area in unmarked vehicles and were able to locate the vehicle, MA registration 88ZA27 parked on Valentine Street near the intersection of Main Street, on the west side of the street. Sgt. Rowland notified Det. LeClare that the vehicle had been located and Det. Urbanowicz and Cpl. Hunt set up surveillance on the vehicle.

A short while later Sgt. Rowland and I met with Det. LeClare and other officers that had responded to Bennington

I then spoke with Sgt. Rowland, who had gone to Dennis Pratt Sr's 114 Pratt Street with his team. Sgt. Rowland advised they had developed information that Delratez had been hanging around with a Darlene Oldham.

Darlene Oldham resides at 113 Valentine Street. The Ford Taurus was located parked directly across the street from her residence.

As we were walking up to Oldham's apartment, a male came out who I knew as Milton Harrington.

I spoke with Harrington about who had been at Oldham's apartment. Harrington advised a black male had been staying with Oldham and described him as a large male.

It was decided that we would check a location Oldham had provided, 326 Pleasant Street upstairs right side apartment. While we were heading to that location, Sgt. Rowland radioed that they had just spotted Delratez and he was running on Safford Street towards Scott Street behind a residence.

I then responded to Scott Street with three officers from North Adams where Det. Urbanowicz and Cpl. Hunt and Sgt. Rowland had the male stopped, on the ground, and were putting him into wrist restraints. I assisted Officer Urbanowicz in getting Delratez back up on his feet.

Delratez is currently a wanted person in the State of Massachusetts. Delratez is a sentenced individual for an assault and battery with a weapon against his wife, Amber Blasi-Delratez. The assault occurred on 01-27-2012 in Clarksburg, MA when Delratez punched his wife in the face and held a knife to her neck and threatened to kill her.

Affidavit

Delratez was convicted of this offense on 05-18-2012 and placed on probation until 11-18-2015. Delratez's Massachusetts Criminal History also indicates a probation violation warrant was issued on 09-13-2013.

On 09-13-2013 the Clarksburg Police Department responded to Amber Blasi (Delratez's) residence for a burglary into the residence committed by her former Husband David Delratez.

Delratez's probation officer obtained a warrant for his arrest when he could not be immediately located.

I received a letter from the Berkshire District Attorney's Office stating they would rendite David Delratez from the State of Vermont on their warrant #1228CR0082 with an underlying charge of Assault by means of a Dangerous Weapon in violation of Massachusetts General Laws c. 265, s 15B a felony punishable by imprisonment in State Prison for a term of not more than Five years.

I was also given a copy of the NCIC entry authorization for Delratez to listed as a wanted person.
